

Summary

A Section 24G Application is being conducted for Portion 2 of the Farm Remkuil No. 259, Caledon. The subject property is located within the rural area of Caledon on actively farmed land. The farm is approximately 56.71 ha in extent and is an actively farmed land, with approximately 47.84 ha in the property currently being farmed. Additionally, an area of 1.7 ha of Western Ruens Renosterveld, endangered vegetation type was cleared on the property without Environmental Authorisation. This application seeks to retrospectively apply for Environmental Authorisation for the unauthorized clearance of indigenous vegetation on Portion 7 of Farm Remkuil No. 259, Caledon. This cleared area, characterized by uneven farming edges adjacent to existing fields, was intended to accommodate increasing agricultural demands and to facilitate improved movement of large-scale farming machinery—challenges previously imposed by the irregular terrain and narrow field margins.


