### **Off-hires and Credits**

*New Rental Bookings and Extensions*: Please notify your Booking Agent via email. Alternatively ring our call centre on 086 111 5193 (Option 2).

*Off-hire Credits*: Off-hires booked during a new month are credited according to when the booking is made as follows:
